# 6. Report of the President

6.1. We have grown our program to include three baseball streams over the last few years.

- Little League which includes Instructional (Coach Pitch and Little League), Minors, Majors and Juniors. Baseball Alberta which includes Calgary North Baseball League (A Level Program) and a AA program. Softball Alberta which include U9, U11, U13, U15, U17 & U 19. Due to this growth our Bylaws need to be revised to include all programs.
- 6.2. 2023 season review: We hosted a two day coaching clinic in December. Our winter program was out of Absolute Baseball Academy for 3 weekends in January. Baseball Alberta tryouts were held last weekend in January and first weekend in February. Softball tryouts are completed in the first couple of weekends in February to assure that teams are completed with apparel before evaluations. Spring training for Baseball Alberta and Softball were held throughout the months of February, March and April. Little league and instructional evaluations in April. All leagues kicked off at the end of April. Two fundraisers were held this year which brings in much needed funding. First week in June we held challenger day. Participated in the Parade in September.






# Income Comparison

- 8.1. **Vice President** Ryan McMillan highlight equipment expenses almost every team received a set of catchers gear. To replace the remaining catcher's gear in the coming year. Tees and nets for softball. Like to start replacing equipment every 5 years.
- 8.2. **Past President** Chris Wallin no report
- 8.3. **Secretary** Lori Maier no report
- 8.4. **Registrar** Amie Harvey 2023 registration was down from 2022 by 40. 2021 and 2022 registration was up. Winter Training camp was very similar up during 2021 and 2022 then slightly down in 2023. Include winter camps. 338 registration in 2023: 116 instructional, 70 Little League, 77 Softball. CRCA membership is being enforced including past years. Significantly short. With new memberships coming in for 2024 can be used for 2023 membership fees. 2024 will have a mandatory section to verify membership. Crushers baseball gets a discount on diamonds with membership for participants. Energizer Night was very successful. Instructional numbers go up most at energizer night. Softball registration is usually closed but we leave registration open longer to accommodate girls wanting to join on energizer night. Will continue with energizer night. Adding additional documentation requirements for 2024 registration.

- 8.6. **Fundraising** Randy Burnette Two draws with the first one being successful but second one was a bit down. Will only do 1 for 2024 but run it a bit longer.

After the first regular season game, no refund will be given regardless of injury or doctor's note.

Articles III, Section 2 – REFUND POLICY be deleted from the bylaws. The Refund Policy will be created inside a CRVLL policy outside of the Bylaws that will be reviewed and approved prior to the opening of registration for each new season.
